Average: Bowler will use highest sanctioned average of at least 21 games for the 2021-22 season. Bowlers without a 2021-22 will use highest sanctioned average of at least 21 games of the 2020-2021 season. If bowler has no average, an average of 220 will be used.

Tournament Director: Rebecca Azurmendi; All decisions made by the director are final.

Sign up and Entry Fee:

\$70 per bowler. Pre-registration and pre-payment is preferred. Optional Scratch Division for \$20 per bowler. A fillable entry form can be found at <http://www.brooklynballreviews.com>. Payment methods available are: Cash, Venmo, CashApp, and Zelle. Electronic entry deadline will be Wednesday March 1, 2023. Please do not send electronic payments after that date. Please submit all non-electronic entries and cash payments to Rebecca Azurmendi.

Walk-Ins are available based on availability.

Prize Fund, Linage, & Expense Fees:

Based on 60 entries

\$48 to prize fund, \$20 to lineage, and \$2 towards expenses.

Entering Averages & Handicap:

Must use highest USBC standard composition average for 2021-22. If no average for 2021-22 season, highest average from 2020-21 will be used. If no 2020-21 season average, bowler will use highest current league average. If using current league, bowler MUST provide current league sheet. If no sheet verification is provided, bowler will use a scratch average of 220. All bowlers are responsible for average verification. Failure to report correct average may result in disqualification. Bowler must report rerates if any over last 5 years. Tournament director reserves the right to rerate.

Start Time, Check-In and Pattern:

Sunday March 5, 2023 @ 10:00 am. Practice will begin at 9:50 am. Check-in will begin at 9:00 am.

Pattern: Will be announced the week of the event.

Lane Movement:

Bowlers on the left lane will move one pair left after each game. Bowlers on the right lane will move one pair right after each game.

Format:

Bowlers will bowl 6 games qualifying across 6 pairs of lanes. Lanes will be assigned on March 4, 2023. Field will be cut to top 10. Bowlers 5 thru 10 will bowl a 1 game roll off. High game from the roll off will make the step ladder finals.

Step Ladder Finals:

Fresh Oil for the step ladder.

5th seed vs 4th seed. Winner vs 3rd seed. Winner vs 2nd seed. Winner vs 1st seed for a Champion to be decided.

Brackets and High Game Pots:

\$5 brackets available for qualifying play. Handicap and Scratch brackets will be available.

\$20 Handicap or Scratch High Game Pot for all qualifying play. High Game pots will be paid out after each game. Brackets and High Game pots will be collected during check-in only. Please do not prepay for brackets or high game pots.
