## 9 Pin Tournament

1. This tournament is only open to 500 Club of Southern Nevada members in good standing. (MEMBERSHIP NEEDS TO BE PAID FOR THE YEAR 2024)
2. This tournament will be a 9-pin tournament, where a first ball pinfall of 9 or 10 will count as a strike. This tournament will be bowled on a single pair of lanes; no moving.
3. This will be a handicapped tournament; handicap based on 90% of 210.
4. Averages will be taken in this order, 1) Highest Winter book average 2023-24; 2) Highest Summer book average of 2023-24; 3) Highest Winter book average 2023-24; 4) Current league average of 21 or more games (attach current league sheets with entry form or you will not be permitted to bowl). If none of the above, bowler will enter with a 210 average
5. Fee for tournament is \$30.00 with \$12.00 going to lineage, \$1.00 club expense, and \$17.00 going to the prize fund. ONSITE SIGN UPS WILL BE \$35.00 AND NEED TO BE SIGNED UP BY 12:15 PM
7. A side pot (3 game total) will be available on site for \$6.00 each for handicap and/ or scratch.
8. Tardy bowlers WILL NOT be allowed to bowl.
9. Tournament Director shall have the authority to handle all questions and have the final say on anything not covered in these rules.
10. Full entry fee must accompany entry form; MAKE CHECKS OR MONEY ORDERS PAYABLE TO 500 Club of Southern Nevada.
11. Bowlers will only be able to receive a refund with a 24 hour notice
